CROP	DISEASE	RATE	CRITICAL COMMENTS
BEDDING PLANTS (ornamental seedlings)	Root Rot Stem Rot (<i>Phytophthora</i> spp) Damping Off	75-100mL in 100L water to 10m ²	Repeat application may be made at 4-6 week intervals if required. Use higher rates on soils high in organic matter.
HERBACEOUS & WOODY ORNAMENTAL PLANTS		25-50mL in 100L water	Apply 300mL solution per 15cm pot or sufficient solution to saturate soil. Use higher rate on soils high in organic matter or in peat.
TURF	Damping Off Grease Spot (<i>Pythium</i> spp)	250mL in 300L water to 100m ²	Apply as a spray uniformly to area. Repeat application at 5-10 day intervals to maintain disease control.
FIELD PLANTING OF YOUNG TREES (non-bearing)	Root Rot (<i>Phytophthora</i> spp)	20-30mL in 15-20L water	Drench sufficient solution around base of plant to saturate root area. Repeat monthly when seasonal conditions could affect tree establishment. Use high rate for higher disease levels.

MIXING:

Add the required quantity of Terrazole EC 240 to the spray tank. No further agitation is required after mixing.

Some naturally occurring individual fungi resistant to Terrazole EC 240 Soil Fungicide and other Group X fungicides may exist through normal genetic variability in any fungal population. The resistant individuals can eventually dominate the fungal populations if these fungicides are used repeatedly. These resistant fungi will not be controlled by Terrazole EC 240 Soil Fungicide or other Group X fungicides, thus resulting in a reduction in efficacy and possible yield loss.
