Tobacco-seedbed	Blue Mould	Old only	High volume applied 6g per 15 litres of water per 60 to 80 square metres	Spray at 7 day intervals commencing 7 to 10 days after emergence. Make the final application four weeks after emergence. Spray to thoroughly wet leaves. DO NOT drench. NOTE: for further protection, apply ZEE-MIL 250 WP as weekly foliar spray commencing 5 weeks after emergence..

GENERAL INSTRUCTIONS:

MIXING AND APPLICATION:

Pre-mix the product into a smooth, thin cream with sufficient water to ensure that all particles are thoroughly wet. Pre-mixed material should not stand for more than 1 hour.

Knapsack sprayers:

Pour the premix into the **partly filled** tank, add remaining water and stir vigorously.

Field sprayers:

Pour the premix into a partly filled tank while vigorously agitating, making sure that the by-pass reaches the bottom of the spray tank. There must be sufficient agitation to keep the mixture stirred before and during spraying. Agitate vigorously from the bottom of the spray tank if material is left to stand.

ZEE-MIL 250 WP is a member of the Phenylamide group of fungicides. For fungicide resistance management ZEE-MIL 250 WP is a Group D fungicide. Some naturally occurring individual fungi resistant to ZEE-MIL 250 WP and other Group D fungicides may exist through normal genetic variability in any **fungal** population. The resistant individuals can eventually dominate the fungi population if these fungicides are used repeatedly. These resistant fungi will not be controlled by ZEE-MIL 250 WP and other Group D fungicides, thus resulting in a reduction in efficacy and possible yield loss.

Since the occurrence of resistant fungi is difficult to detect prior to use, United Phosphorus Ltd accepts no liability for any losses that may result from the failure of ZEE-MIL 250 WP to control resistant fungi.

PROTECTION OF WILDLIFE, FISH, CRUSTACEA AND ENVIRONMENT: DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

STORAGE AND DISPOSAL: Store in the closed, original container in a dry, cool, well ventilated area out of direct sunlight. Single rinse before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on-site. Dispose of at a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS: Avoid contact with eyes and skin. Do not inhale dust or spray mist.

FIRST AID: If poisoning occurs, contact a doctor or Poisons Information Centre. If swallowed, and if more than 15 minutes from a hospital, induce vomiting, preferably using Ipecac Syrup APF.
