<b>SITUATION</b>	<b>RATE</b>	<b>CRITICAL COMMENTS</b>
Minimise antagonism to tank mixes with flowable herbicides.	2L/100L of spray solution.	Half fill spray tank with clean water and start agitation. Add Conquest AMSUL 417 LIQUID HERBICIDE ADJUVANT through tap opening of spray tank.
Improve performance under adverse environmental conditions.		With agitation still running, add the required flowable herbicide to the tank and mix thoroughly. Add the required amount of Glyphosate based product and the remaining water; mix thoroughly. Add surfactant, if required, near the end of the filling process to minimise foaming. Always maintain adequate agitation during application and use the tank mix promptly.

**GENERAL INSTRUCTIONS:**

Conquest AMSUL 417 LIQUID HERBICIDE ADJUVANT should be used with non-selective herbicides only, as with some selective herbicides use may result in loss of selectivity and therefore crop damage. Ammonium Sulphate may be corrosive to metal parts of the sprayer. Thoroughly flush tanks, pumps and nozzles with water after use.

**PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT:**

DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

**STORAGE AND DISPOSAL:****KEEP OUT OF REACH OF CHILDREN**

Store in the closed original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight.

Triple or preferably pressure rinse empty containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.
