Granule formulations are designed to be added to large volumes of water and dispersed slowly under agitation. When using larger boomsprays and unable to add granules directly to a large volume in the tank via the top of the boomspray, pre-mixing may be necessary as follows:

Partly (30%) fill the boomspray tank with water.

Slowly add required amount of Imtrade Edge 500 WG Herbicide for the area to be sprayed into Granni Pot® or other pre-mixing vessel while agitating well.
